Explanations:-

1. Vacant seats of ST-AIC will be offered to SC-AIC category if no ST-AIC candidate is available.
2. Vacant seats of UR-PWD-AIC category will be offered to UR-AIC if no UR-PWD-AIC candidate is available. \*\*
- \*\* 3. For the vacancies which are to be filled by UR-AIC, if the candidates of AIC are lower in merit than the already admitted candidates of any other category other than UR-AIC, then the seats will be filled from the candidates of that category. (The seats will be filled up according to latest seat matrix).**
4. Vacant seats of WL category (ward of land owners whose land has been acquired in Rajeev Gandhi Education City, Rai) will be offered to UR-HR category if no WL category candidate is available.
5. Merit List will be prepared & displayed on the notice board at 12:30 PM and the counselling will start immediately.
6. A Merit List will be prepared based upon the physical attendance of the candidates. The seats which fall vacant (if any) after the final counselling will be offered on merit basis to the candidates who marks their attendance on 02.08.2019. Out of this merit list, the candidates may be called for admission against vacant seats (if any) upto 16.08.2019.
7. There may not be any further counselling beyond 02.08.2019 and the candidates will be contacted personally as per their above merit list. Therefore, the candidates must write their 02 working phone numbers & email also on attendance sheet.
