NOTIFICATION

1st Provisional Merit List : BB.A. LL.B. (Hons.)

With reference to the Notice issued vide No.: DBRANU/AR&S/2026/398 dated 06.05.2026 and DBRANU/AR&S/2026/441 dated 02.06.2026 the **1st Provisional Merit List (Category wise)** of shortlisted candidates for admission to BB.A. LL.B. (Hons.) Programme for the Academic Session 2026-27 is hereby published and attached at **Annexure 'A'**.

The provisional merit list has been prepared solely on the basis of the CLAT-2026 (UG) All India Rank of the candidates who had applied within the stipulated timeframe, paid the prescribed application fee and uploaded valid supporting documents in support of their claim. Candidates who submitted applications without supporting documents and application fee have not been considered.

Note:

If any candidate believes they were excluded from the merit list despite having submitted the complete application form, supporting documents and fee, they may submit a written representation through **email only** to the Admission Branch/Committee at admission@dbranlu.ac.in with **subject** of email "**Representation w.r.t Allotment of Vacant Seats : BB.A. LL.B. (Hons.)**", along with all relevant supporting documents.

No other mode of representation shall be entertained. Grievance submitted after **04:00 PM on 24.06.2026** shall not be considered.

After redressal of genuine grievances, a revised list of candidates selected for provisional admission (under various categories) shall be published on the University Website, if any.

Instructions to Shortlisted Candidates:

1. All admissions are purely provisional and subject to physical verification of original documents at the time of reporting and resolution of grievance, if any.
2. The shortlisted candidates are required to deposit the full course fee of **₹1,61,750/- (Rupees One Lakh Sixty-One Thousand Seven Hundred Fifty only)** till **30.06.2026, by 05:00 PM** through the link <https://forms.eduqfix.com/drbrnational/add>. Failure to submit the fee within the stipulated timeframe shall result in cancellation of candidature and forfeiture of the allotted seat, which shall then be offered to the next eligible candidate in order of merit.
