No other mode of representation shall be entertained. Grievance submitted after **03:00 PM on 30.07.2025** shall not be considered.

After redressal of genuine grievances, a revised list of candidates selected for provisional admission (under various categories) shall be published on the University Website, if any.

Instructions to Shortlisted Candidates:

1. All admissions are purely provisional and subject to physical verification of original documents at the time of reporting and resolution of grievance, if any.

2. The shortlisted candidates are required to deposit the full admission fee of **₹1,23,000/- (Rupees One Lakh Twenty-Three Thousand only)** till <u>30th July, 2025</u> through the link <u>https://forms.eduqfix.com/drbrnational/add</u>. Failure to submit the fee within the stipulated timeframe shall result in cancellation of candidature and forfeiture of the allotted seat, which shall then be offered to the next eligible candidate in order of merit.
