- 3. If large number of applications are received, only those candidates who are short listed on the basis of qualification, experience, tenure and level of services in the relevant field shall be considered for selection/ called for interview.
- 4. The required qualification and relevant experience etc. for eligibility shall be determined as on interview of receipt of application.
- 5. The prescribed essential qualifications and experience indicated are bare minimum and mere possession of the same will not entitle any candidate to interview.
- 6. Application not submitted in prescribed format or incomplete in any respect shall be liable for rejection.
- 7. Officer/employee employed on deputation basis shall be paid salary as per University Foreign Service Rules and HCS Rules as applicable.
- 8. No TA & DA will be paid for attending the interview.
