Failure to do so will result in cancellation of the admission offer, and the seat shall be offered to the next eligible candidate on the waitlist.
4. Wait-listed candidates shall be considered for admission only in the event of a vacancy arising due to the failure of a selected candidate to deposit the fee or fulfil eligibility requirements. Mere appearance on the waitlist does not confer any right to admission.
