ELIGIBILITY CRITERIA:

1. A Five Year Integrated Law Degree or Three Year Law Degree-LLB/ Or an Equivalent Examination Degree with a minimum of Fifty percent (50%) marks or its equivalent grade in case of candidates belonging to General/OBC/PWBD categories and Forty-Five percent (45%) marks or its equivalent grade in case of candidates belonging to SC/ST categories.
2. Candidates appearing in their final semester examination of qualifying examination or awaiting results of the qualifying examination are also eligible to apply. Such candidates who are appearing in the undergraduate course will be provisionally admitted subject to the submission of pass result fulfilling the conditions for the undergraduate qualifying degree (Five-year integrated law degree/three-year law degree-LLB), at the time of counselling or any other date as specified by the University.

3. **For Working Professionals:** Law Graduates with at least three (03) years of experience in government (Central/State), PSUs, industry, research, law firms, companies, advocacy, etc. are eligible to apply. To verify their experience, candidates must submit a Certificate of Experience issued by the relevant office, institution, authority, or their respective Bar Council/Association when submitting the application form.

SPECIALIZATION OFFERED:

DBRANLU offers **four distinct specializations**, each meticulously designed to enable LL.M. candidates to explore in-depth areas of law:

1. Criminal Law
2. Family Law
3. Constitutional & Administrative Law
4. Corporate Law

BASIS OF ADMISSION:

Admission to the LL.M. (Two Year) Programme shall be made on the basis of merit prepared from the marks obtained in the qualifying examination and interview conducted by the university, as per the Admission Policy of the University. The final merit list shall be prepared after due verification of eligibility and documents submitted by the candidates.

Admissions will be based on strictly on academic merit and a Presentation/Interview conducted at the time of admission. The merit list will be prepared according to the following criteria:

- Marks obtained in the qualifying Bachelor's Degree in Law: 50%
- Presentation/Interview: 50%

GUIDELINES/INSTRUCTIONS

After the application submission period concludes, a comprehensive list of eligible candidates shall be prepared, which shall be used for calling candidates for further admission process.

1. Provisionally shortlisted candidates for admission to the LL.M. (Two Year) Programme shall have to pay the requisite fee through the payment link or payment portal available on the University website under the Student Corner. Failure to do so will result in cancellation of the admission offer, and the seat will be offered to the next eligible candidate.
2. The admission of any candidate is liable to be cancelled without further notice, at any time during the programme, if it is found that the candidate has produced fake/forged certificates/documents, or has indulged in any act of misconduct/indiscipline/moral turpitude, or has concealed any relevant information at the time of seeking provisional admission. Such candidates shall also be liable to be prosecuted under the Law.
3. Any attempt by the candidate or anyone else on his/her behalf to influence or pressurize any Authorities/Admission Committee of the University, directly or indirectly, for out-of-rules admission, shall disqualify the candidate from the admission. Such candidates shall also be liable to be prosecuted as per the provisions of Law.

4. The provisional admission of candidates for the said programme shall be subject to such rules and regulations as may be framed by the University from time to time.
5. Candidates must produce an official CGPA/Grades to percentage conversion formula or certificate at the time of the application.
6. Candidates applying under reserved categories shall have to produce valid certificates in support of their claim. For OBC (NCL Only)/EWS certificates to be produced for the current financial year i.e. issued on or after 01.04.2026.
7. Seats are subject to change at the discretion of the Competent Authority.
8. Admitted students will not be allotted hostel accommodation as a matter of right. However, accommodation may be provided subject to availability

Note:

1. Candidates must ensure that they provide a valid and functional email ID and mobile number while filling out the application form, as all communications will be made via email/SMS only.
2. All related updates will be uploaded on the University website only. Candidates are therefore advised to visit the University website (www.dbranlu.ac.in) regularly.
3. Applications that are incomplete or do not satisfy all prescribed requirements shall be deemed ineligible and will not be considered further.
4. For detailed information regarding the LL.M. Programme, candidates may visit the University website
5. Submission of application shall not confer any right to be called for the interview.
