General Terms & Conditions/Instructions:

1. Admissions against aforementioned seats are now open to all candidates, regardless of whether they have previously applied. Seat allotment will be based solely on the All India CLAT UG 2025 Rank.
2. The University reserves the right to maintain waiting list to fill any future vacant seats, if any.
3. A merit list will be prepared on the basis of CLAT UG 2025 score (All India Rank) for all candidates who mark their attendance on the day of counselling. **Late comers after 02:00 pm** will not be entertained and Physical presence of the candidate is mandatory. No representation in this regard shall be entertained.
4. Admission will be provisional and subject to the verification of all the documents and information/facts given in the candidate's application form.
5. Provisionally admitted candidates shall be required to deposit the full admission fee of **₹1,23,000/- (Rupees One Lakh Twenty-Three Thousand only) + Rs. 15,000 Mess Fee** through online mode on the same day. Failure to deposit the fee on the same day shall result in cancellation of admission, and the seat may be offered to the next eligible candidate. However, in genuine cases, the fee submission deadline may be extended by up to one day, subject to prior approval.
6. Any misrepresentation or concealment of facts shall result in cancellation of admission and the candidate may be barred from future admissions.
7. Document verification of shortlisted candidates will be held on the same day; therefore, candidates must carry the following original documents along with two sets of photocopies at the time of document verification:
