1. The Interview shall consist of 30 Marks in total, with 15 marks allocated for Domain Knowledge and 15 marks allocated for Research Aptitude.
2. For the Research Aptitude component, all candidates are required to present a brief outline of their proposed research work through a PowerPoint Presentation (PPT) of not more than 7 (seven) slides. The presentation shall cover the following elements:
 - i. Aim & Objective and Importance of the Proposed Research;
 - ii. Statement of the Problem;
 - iii. Hypothesis;
 - iv. Proposed Methodology; and
 - v. Research Questions.
3. Candidates are required to bring their PPT in a Pen-Drive/USB Drive on the day of Interview, to be presented before the Doctoral Research Committee. No other mode of presentation shall be accepted.
4. Candidates appearing for the interview are required to produce, in original, all mandatory documents pertaining to their eligibility, including Degree(s), DMC(s) up to the qualifying examination, Category Certificate (wherever applicable), Experience Certificate (if applicable), and any other relevant document, along with a self-attested photocopy of each.
5. The list of provisionally eligible candidates, prepared as per the guidelines mentioned in the Admission Notification, is enclosed herewith as **Annexure-A**.
