Inviting Online applications for admission to B.A. LL.B. (Hons.) 5-Yr Programme

All concerned are informed that online applications are invited for following vacant seats for admission to B.A. LL.B. (Hons.) 5-year Integrated programme for Academic Session 2025-26.

Applications are invited from the interested and eligible candidate (who have applied for and appeared in the CLAT and passed 10+2 or an equivalent examination with a minimum of Forty five percent (45%) of marks or its equivalent in grade or Forty Percent (40%) of marks or equivalent in case of candidates belonging to SC/ST/PwD categories.) for admission to B.A. LL.B. 5-Year integrated course against the vacant seats. Applicants can directly apply to the University through google form link (<https://forms.gle/h3AyoXyrsmAEhbnD6>) after depositing the **non-refundable registration fee of Rs. 2,000/- (Rs. Two Thousand Only)** through Q-fix Link (<https://forms.eduqfix.com/drbrnational/add>) or payment link available on university website under the student corner named as New Admission Fee Portal. The admission will be made strictly on the basis of All India CLAT Rank based merit list.

Guidelines/Instruction for Online Counselling:

1. After the application submission period concludes, a comprehensive merit list will be prepared based on their CLAT-2025 score (All India Rank). This merit list will be published on the University website and will be used for current seat allocations as well as for filling any future vacancies that may arise due to unfilled seats.
2. Shortlisted candidates shall have to **pay the admission fee of ₹1,23,000/-** through the link (<https://forms.eduqfix.com/drbrnational/add>) or payment link available on university website under the student corner named as New Admission Fee Portal. Failure to do so will result in cancellation of the admission offer, and the seat will be allotted to the next eligible candidate in the respective category. Please note that all admissions are provisional and subject to successful verification of documents & facts given in the candidate's application form.
3. The admission of any candidate is liable to be cancelled without giving any further notice forthwith or at any time during the period of the entire course of study, if it is found that the candidate has/had produced fake/forged certificate(s)/document(s) or indulged in any act of misconduct/indiscipline/moral turpitude or has/had concealed any other relevant information at the time of seeking provisional admission. Such a candidate is also liable to be prosecuted under the Law besides being debarred from appearing in any of the Entrance Test of the University in future
4. Only High School/10th Standard mark sheet certificate for proof of age and Intermediate/10+2 exam mark sheet/Grade sheet for ascertaining qualifying percentage of marks, shall be considered for B.A. LL.B. (Hons.) Programme.

Any attempt by the candidate or anyone else on his/her behalf, to influence and or pressurize any Authorities/Admission Committee of University directly/indirectly for his/her out of rules admission, shall disqualify, the candidate from the admission. 6. The provisional admission of the candidates for the said programme shall be subject to such rules and regulations as may be framed by the University from time to time.
