



- Font: Times New Roman
- (Heading/Title of Font Size: 14 pt. manuscript), 12 pt. (Main text), 10 pt. (Footnotes)
 • Line Spacing: 1.5 (Main text), single spacing
- (Footnotes)
- Margins: 1 inch on all sides
- Citation Style: Bluebook 21st Edition

SUBMISSION GUIDELINES

- Essays must be original and unpublished.
- The submissions must be relevant to the themes provided.
- Submissions should be in PDF format via the designated submission portal.
- will Plagiarism above 20% result disqualification. The authors will also be required to attach a plagiarism report of any recognized software.

Individual authorship and Co-authorship (maximum of 2 authors per essay)
