Notification

Submission of Freeship Card under PMS (SC) Scheme

It is hereby notified that students belonging to the Scheduled Caste of Haryana State who are eligible under the PM Scholarship Scheme (SC Haryana) and have been issued a valid **Freeship Card** by the competent authority may submit the same to the University at the time of admission to avail exemption from pre-payment of tuition fees and hostel fees as per the applicable scheme guidelines.

Such students will be permitted to continue their studies without pre-payment of tuition fees and hostel fees, subject to fulfilment of all conditions prescribed under the PMS (SC) Scheme and timely completion of all scholarship-related formalities on the designated portal(s).

Further, apart from the tuition and hostel fees, the student shall pay the remaining fees and charges (as per fee structure) strictly as per scheduled timelines or as and when demanded by the University.

However, it is specifically clarified that the issuance or submission of a Freeship Card **does not guarantee** the sanction or disbursement of scholarship from the concerned department/ministry. In the event the scholarship is not granted, is rejected, is cancelled, or the amount is not released to the beneficiary student for any reason whatsoever, the student shall be personally responsible to deposit the entire tuition fees and hostel fees **on or before the end of the academic year in which admission has been taken**, and shall also pay all other University charges/dues as per rules.

All concerned students are advised to carefully read the PMS (SC) Scheme Guidelines and keep track of the status of their scholarship applications.
